We ask that interested applicants return their completed applications **no later than July 25, 2025.** Incomplete applications will be held until all materials are received. Please note that we may sell out so get your applications in asap.

Incomplete applications, paperwork and requirements are not eligible to be included.

Ground Rules

APPLICATION: Please complete the entire Exhibitor Application and submit it to Pacific Pride Foundation ("PPF") along with full payment and all required materials (application, certificate of insurance, and application for special event), as laid out in these ground rules. We cannot reserve booth space for you if we do not receive all required materials before the application due date given above. Please submit all of your materials at once.

PPF reserves the right to decline any application for any reason and without explanation.

INSURANCE: You are responsible for your own insurance. Before the application due date, you must submit to PPF a Certificate of Insurance naming Pacific Pride Foundation as additional insured with liability limits of at least \$1,000,000.

PAYMENT: PPF will not refund any portion of payment once your application has been accepted. Make all payments online.

SECURITY DEPOSIT: A security deposit is not required. If any damage occurs, you will be invoiced and responsible for **damage charges.**

SANTA BARBARA BUSINESS LICENSE: See last page for details

BOOTH SPACE: Once your application has been approved, we will reserve booth space for you at the Pacific Pride Festival. Each space measures approximately 10' x 10', and you must confine all of your business to this assigned space.

Exhibitors will be directed to their space on the morning of the event. You are responsible for setting up and subsequently dismantling and removing any tablecloths, decor, or other fixtures that you bring with you. You must complete setup between 7 AM and 10:30 AM on the day of the festival, and you must perform all cleanup and dismantling between 7 PM and 9 PM (also on the day of the festival). You must return your space to the same condition you found it at the start of the event by 9 PM on the same day.

BOOTH STRUCTURE: On the day of the event, PPF will outfit your booth space with a canopy, one table, and two chairs for your use. You may request additional materials for a fee. Electricity is not available onsite. Any generator brought in must be pre-approved by Pacific Pride Foundation.

Generators: You are responsible for any generators provided and must make sure they are approved by the City of Santa Barbara.

Space Rental Application Guidelines

To ensure an enjoyable day, please follow the guidelines listed below:

LOAD-IN

You are permitted to drive your vehicle to your tent space within the load-in/load-out times you will be assigned. Vehicles will not be allowed to remain on the field. More communications will come 1-2 weeks prior to the event.

DO NOT STAKE ANYTHING INTO THE GROUND

This is a City of Santa Barbara Parks & Recreation rule. You will be asked to remove anything we see staked into the ground. Please plan for other means to display items.

STAY FOR THE WHOLE EVENT

Please do not pack up your tent and leave prior to 7:00 pm unless you have previously submitted a special request. You have been placed based on any needs you have requested. We thank you for committing to engage and have fun with the community all day long.

PETS

All pets must remain on leash at all times. Anyone with pets off-leash will be asked to put them on leash immediately or asked to leave the event. Anyone not complying will be asked to exit the event.

TENT VENDORS:

- The entire area will be fenced in with security.
- You will be provided with a detailed layout and clear instructions.
- Please follow your times. If you arrive earlier or later than the assigned times, you may be asked to hold for safety reasons.
- No refunds once your application has been received and accepted.
- Pride will take place rain or shine so please be prepared for any weather conditions.
- All trash must be compacted and disposed of in the dumpsters at the close of the event.
- No beverages may be sold (alcoholic or non-alcoholic. Pacific Pride Foundation holds the right to be the exclusive vendor of beverage sales at Pacific Pride Festival.
- No food may be prepared or sold on site.
- Electricity is not available onsite. All generators brought on site must be pre-approved by the City of Santa Barbara.

FOOD TRUCKS ONLY

• All vendors must adhere to Health Department regulations in preparation for serving food. Santa Barbara Health Department will be on site to inspect food trucks prior to the opening of the event.

ALL VENDORS MUST HAVE A CURRENT BUSINESS LICENSE. (Churches are exempt).

All vendor applications must provide a business license sent to email below. All applications received by their office will be mailed back with instructions to apply for the business tax certificate online. Attached are two letters that their office generates to inform taxpayers – one letter is for taxpayers that have paid the annual business tax, and the other letter is for taxpayers that have not paid the annual business tax and are not in our system. Below is the chart included in the letter that lists some business descriptions for vendors to choose.

All businesses that are present at the event and advertising their business or organization must apply for the business tax certificate.

The fee is dependent on the type of business conducted, and if the business is based inside or outside the City of Santa Barbara. The first business description listed below is a minimum fee of \$30.00 + a \$4 state disability access fee. The tax is paid annually, so vendors can use the same tax certificate for multiple events.

Nonprofits still need to be listed on the list of vendors and must file in our system. We do have a business description for non-profits that mark them as exempt from paying the business tax. They essentially just need to be in our system.

This is a requirement by the City of Santa Barbara.
